BACKGROUND:

The Shasta Union High School District's Board of Trustees is currently elected under an "at-large" election system, where Board members are elected by voters of the entire District. On October 19, 2023, the Board adopted Resolution No. 23-195, signaling its intent to transition to by-trustee area elections. In a by-trustee area election system, each Board member must reside within the designated trustee area boundary and is elected only by the voters in that trustee area. The Board will hold the first of two public hearings to gather input on composition of potential trustee areas pursuant to Elections Code section 10010. The public is invited to participate and make comments during the public hearing. The National Demographics Corporation will conduct a presentation regarding the demographic process to draw trustee-area boundaries.
