Currently, I wish to stand as a bridge between youth in the Shasta Union High School District and School Board members because, I have a deep passion for communicating other students' needs, wants, and desires for changes within the Shasta Union High School District.

Throughout my surplus experiences with leadership positions, communication skills, conferences, meetings, and more I feel that I would bring to the table not only a different perspective, but valuable skills needed for the position as well. With my experience with Youth Action Council, Youth Peer Court, student council, and more I have gained leadership experience and valuable communication skills. Within my different perspectives, I've seen how troubled and excellent children have faced hardship which is why I can offer different perspectives to the School Board. I have known others who have been impacted by family situations severely and impacted by friends at school which gives me the experience I need, as I have helped and tried to guide students through troubled times they have faced. The respondent meets, before the court, with a peer advocate who discusses what dispositions are available and related to the case. The respondent who made a questionable choice then goes to court in front of a jury of other youth and answers questions from the juror. During the court meeting, the appropriate dispositions are decided for the respondent. Youth Peer Court is a wonderful opportunity that I gained volumes of knowledge and skills from. I have been a part of Youth Peer Court since August of 2022, and since then have seen many different cases, and kids come through the program and have had many different experiences. One of the more memorable experiences I have had through Peer Court was when I gained the opportunity to speak in front of Redding Rotary Club about Peer Court and the countless guidance and service we have given to the youth of Shasta County.

While I have had many opportunities to flourish in different environments like Youth Peer Court and Youth Action Council however I have gained more experience as well through more extracurriculars and personal experience. Some other extracurricular activities that I've been involved in were being on a Tennis team, being a cheerleader for two seasons, being involved in JV Softball for two seasons, being involved in Odyessy of the Mind, two plays put on by Grant Elementary school, being involved in student council for two years achieving a Secretary and Vice President position, being a Nation Honors Society member, public speaking at Poetry OutLoud, music club, volunteering with stage crew for helping the play Fiddler on the Roof last year, and in all semesters in highschool achieving some type of honor roll all while balancing advanced placement and honors classes in high school.
